The purpose of a foster home is to allow a rescue dog/cat to live in a home environment whilst awaiting adoption. This arrangement allows both the foster family and the rescue organization to evaluate the dog/cat and to work with the dog/cat to reincorporate him/her back into a home environment. A home environment is so much less stressful on the dog/cat than a boarding facility or shelter. The social exposure the dog and cat receives (walks, outings, structured meal times, exposure to other animals) often supports the smoother integration of the dog into a permanent home.

KAWS considers our Foster Families to be essential to the welfare and proper placement of our dogs/cats, and wishes the experience to be enjoyable and free from misunderstanding or difficulty.

Foster will default into an automatic adoption after three(3) months. Adoption fees will be waived in this instance

The Foster Family will follow all procedures and guidelines of KAWS regarding the foster dog/cat and will not make decisions or take actions regarding the dog/cat's veterinary care or placement/adoption without prior approval from KAWS.	Sign in block
The veterinarians working with the KAWS animals are approved for medical services provided to our rescued animals. Should any major procedure be required, the foster family must contact KAWS and ideally, the pre-approved veterinary team will be used for all procedures.	

<p>The Foster Family will provide the dog/cat with humane and loving care and will maintain the health and wellbeing of the dog/cat in accordance with any relevant municipal bylaws and ordinances whilst the dog resides with the Foster Family.</p>	
<p>The Foster Family will provide the dog/cat with adequate food, water, shelter, affection, socialization, exercise, medical assistance and to strive to increase the social integration and adoptability of the dog/cat.</p>	
<p>The Foster Family will provide weekly updates / photos to the KAWS Adoption Agent in order for him/her to promote the dog/cat for adoption on the FB social media page. If the Adoption Agent is unable to find a suitable home within six months after the dog/cat has been taken in foster care, this application will default into an adoption with the exception that we at KAWS waver the adoption fees.</p>	
<p>If the dog/cat can no longer be kept by the Foster Family, the family will notify KAWS immediately. THE DOG / CAT SHALL NOT BE SOLD, ABANDONED, RELINGQUISHED TO A SHELTER OR POUND OR ANY THIRD PARTY.</p>	
<p>THE FOSTER FAMILY UNDERSTANDS THAT KAWS AND IT'S REPRESENTATIVES HAVE LIMITED INFORMATION REGARDING THE TEMPERAMENT OF THE DOG/CAT</p>
